Nothing herein shall make us partners. The Sponsor and the Garden City Youth Athletic Association are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent as specified herein.

The Sponsor shall have the right to use the following term in advertisements, posters, brochures, newsletters, etc.: "Sponsor of a Garden City Youth Athletic Association team/league". Sponsorship does NOT give the Sponsor the right to use the word "official" in connection with its Sponsorship. Any reference to the Sponsorship under this agreement must make it clear that the Sponsorship is with a team or teams in the Garden City Youth Athletic Association only and NOT for Little League Baseball. Use of the "keystone logo" or any other logo of Little League Baseball or P.O.N.Y. is prohibited, unless permission is expressly granted in writing by L.L.B.I. and/or P.O.N.Y.
